Virgin Bull Nomination
Bull Nomination Entry Deadline: January 15th, 2025

Rules for Virgin Bulls:

1. Bulls should be virgins.
2. Bull birthdates: September 1, 2023 – April 15th, 2024
3. Bulls must be registered with their respective breed association and have EPD values for at least birth weight, weaning weight, milk and yearling weight.
4. Bulls must be eligible for transfer of ownership to the buyer.
5. Bulls must pass and have documentation of passing a breeding soundness exam from a qualified veterinarian no more than 30 days prior to sale date. Documentation must be turned into the sales management when bulls are delivered on Friday, April 25th, 2025.
6. Recommended Vaccinations and best management practices are the following:
 - a. Negative for BVDV
 - b. 7-way Blackleg (Clostridial diseases)
 - c. 5-way Leptospirosis - Vibriosis
 - d. IBR-PI3-BVD-BRSV
 - e. Bulls should be treated for internal and external parasites within 30 days prior to the sale using a quality product as a best management practice.

The above vaccines should be given twice (a primary and booster) in accordance with the specific vaccine label directions or within a veterinarian-client relationship in accordance with Beef Quality Assurance (BQA) guidelines.

7. Each bull will be screened for structural correctness, overall quality, foot structure and adequate weight per day of age. The sales management has the right to refuse inferior quality bulls.
8. Bulls must not have been implanted with a growth implant at any time during their life.
9. Bulls will need to be parent verified through DNA, and be free from genetic abnormalities.

Sale order will be determined by Black Belt Cattle Marketing once all consignment females and bulls are received at the sale facility on Friday, April 25th, 2025.
